Ken Hardy seconded, motion passed by yes votes by all who were present.

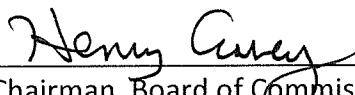

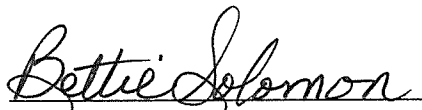
