The time was noted at 6:20 p. m.

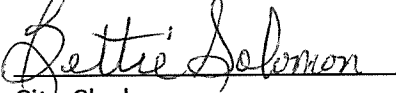
RE-OPEN MEETING: Ken Hardy motioned to re-open. James seconded motion passed by yes vote by all who were present.
