This answer shall state what property, money, and wages, except what is exempt, belonging to the defendant, or debts owed to the defendant, you hold or owe at the time of service of this summons and between the time of such service and the time of making your first answer. **Thereafter, you are required to file further answers no later than 45 days after your last answer.** Every further answer shall state what property, money and wages, except what is exempt, belonging to the defendant or debts owed to the defendant, you hold or owe at and from the time of the last answer to the time of the current answer. **The last answer required by this summon shall be filed no later than the one hundred ninety-fifth day after you receive this summons.** Money or other property admitted in an answer to be subject to continuing garnishment must be delivered to the court with your answers. **Should you fail to file answers as required by this summons, a judgment will be rendered against you for the amount the plaintiff claims due by the defendant.**
