Ordinances shall be considered and adopted or rejected by the board of commissioners in accordance with the rules which it shall establish; provided, however, an ordinance shall not be adopted the same day it is introduced, except for emergency ordinances provided in [Section 2.24](#) or upon unanimous consent of all members present at the meeting at which the ordinance is introduced. Upon introduction of any ordinance, the clerk shall as soon as possible distribute a copy to each commissioner and shall file a reasonable number of copies in the office of the clerk and at such other public places as the board of commissioners may designate.”

Ken Hardy seconded; motion passed by a yes vote by all who were present. No oppositions.
