The regular meeting of the Pulaski County Commissioner was held at 10:00 a.m. on April 8th, 2024. Commissioner Mashburn led the Pledge of Allegiance and Troy Davis gave the invocation.

The Proclamation for Bible Reading Marathon Week being held April 26 through May 2, 2024 was signed. They announced they would have an opening ceremony at 6pm on April 26th and food trucks available.

Resolution 2024-6 to raise Juror and Bailiff pay per the Grand Jury recommendations was signed.

The CJA/G-NCJA and Vendor CJIS Network and Data Agreement with Total Computer Solutions was signed.

The TTL, Inc. Proposal for Phase I Environmental Site Assessment for CDBG – Senior Center project was signed.

The rezoning request for Parcel ID 2T39188004A – Vienna Hwy to rezone to M-U County Mixed Use was approved.

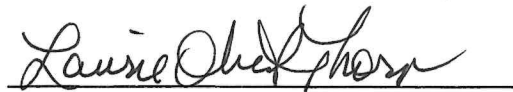
