Minutes of Regular Meeting

The regular meeting of the Pulaski County Commissioner was held at 10:00 a.m. on December 1, 2025. Commissioner Mashburn led the Pledge of Allegiance and gave the invocation.

The Zoning change request for Parcel ID 118B3830008 - 32 Stevens Rd was tabled by the Planning and Zoning board on 11/20/25. Commissioner Mashburn denied the request because it does not fit the current county zoning but will waive the reapplication fee, if needed.

The Zoning change request for Parcel ID T1183840008 – 242 Eastman Hwy was tabled by the Planning and Zoning board on 11/20/25. Commissioner Mashburn denied the request because it is not needed for the homeowner to get a loan since mixed use allows residential. A letter was provided to the homeowner explaining the situation.

The 5-year lease for a John Deere 2025 6M 130 Cab Tractor was signed. This equipment is used to mow along the right of way areas.

The County received a Star Amnesty grant to provide a Scrap Tire Amnesty Event from December 8-12, 2025. Collection is at the County Barn located at 46 County Camp Rd only.

The CoStar License Agreement for Tax Assessment comparison data was signed.

The Harris Software Solutions 2026 agreement to print Tax Assessor notices was signed.

The contract with Match Point Tennis was signed. This project will resurface the existing courts into 6 new Pickleball Courts with lights and fencing at the Recreation Department. Director White will look into possibly using the gymnasium for indoor pickleball areas in the winter.

The Middle Georgia Regional Commission Council Appointments for 2025 are Jenna Mashburn, Bernice Banks, Sara Myers, Kyle Goss and Ramsey Howard.

Lynn Johnson presented the Chamber of Commerce report.

Jamie McDonald presented the Economic Development report and introduced her new assistant, Melissa Clay.

Ms. Marilyn Jelks expressed concern over the size of the deer crossing signs on Davis Rd and wants them placed closer to Lumpkin Smith Rd. Ms. Jelks was also concerned about the water running off near her driveway and a smoother transition on 341 South near Bembry Mill. The Commissioner will check with the road supervisor, Mr. McIntyre, about ordering bigger signs and contacting Ms. Davis to discuss how to even out her driveway. Commissioner Mashburn gave her the DOT Perry office number to discuss the 341 issue since this is a state road.

Mr. Quick asked Ms. McDonald about the price of a ¼ page ad for the digital sign.
