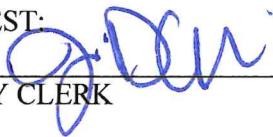
The time was noted at 6:48 P.M.

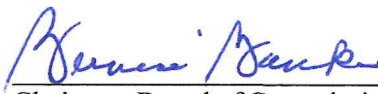
